GENERAL REQUIREMENTS :

The following must be submitted :

1. Current passport valid for travel to Thailand (at least 6-month validity)
2. One completed and signed application form
3. Two identical passport-size photographs (2" x 2") which must be taken within 3 months
4. Photo Copy of Confirmed round-trip ticket
5. Confirmed hotel reservation or proof of accomodation in Thailand
6. Evidence of adequate finance (if any) e.g. previous six months Bank Statement

FEES (only cash accepted and non-refundable) :

VISA Fees :

- 1) Non-Immigrant visa "B" For 3 years Rs. 14,000/- (multiple entry)
- 2) Non-Immigrant visa Rs. 2,800/- (single entry) and / or Rs. 7,000/- (multiple entry)
- 3) Tourist visa Rs. 1,400/- (single entry)
- 4) Transit visa Rs. 1,100/- (single entry)

IMPORTANT INFORMATION

- * Applicants must submit their applications during 09.00 - 12.00 hrs. and may collect their passports the next working day during 09.00 - 12.00 hrs.
- * Any false statement declared in the application form including imitated signature will result in rejection of application.
- * Visa is granted in accordance with the purpose of visit. Recommendation letter and additional documents may be required. All original documents must be presented for verification.
- * Validity of Visa is 3 months Visitors must enter the Kingdom of Thailand before the expiry of the visa.
Validity of stay from date of entry is
Transit visa 30 days
Tourist visa 60 days
Non-Immigration visa 90 days
(Validity of stay is subject to approval of the Immigration authority)
- * Indian national who wishes to work in Thailand must have a prospective employer applying for a temporary work permit who will send an approval letter from Thailand's Ministry of Labour to the applicant to apply for a non-immigrant visa to enter Thailand. Engaging in any profession without work permit is illegal.

IMPORTANT ADVICES

*** VISA HOLDER IS REQUIRED TO HAVE IN HAND CURRENCY WHEN ENTERS THAILAND:**

- (1) Non-immigrant visa : at least equals to 20,000 Baht per person or 40,000 Baht per family
- (2) Tourist visa : at least equals to 20,000 Baht per person or 40,000 Baht per family
- (3) Transit visa: at least equals to 10,000 Baht per person or 20,000 Baht per family

- * Indian national is eligible to apply for tourist visa on arrival at airports in Thailand if plans to stay not longer than 15 days. Such visa holder is required to have in hand currency at least equals to 10,000 Baht per person or 20,000 Baht per family

- * **The Royal Thai Consulate-General, Kolkata reserves the right to reject any application.**
- * **If a visa is not issued to me, I shall not request any refund of visa fees paid to the Royal Thai Consulate-General, Kolkata**
